Business Item #1 Regarding Special Day offerings and DMF distribution

It is recommended by the Regional Board that the Regional Assembly of the Christian Church in Georgia meeting November 13-14, 2015 at First Christian Church of Atlanta, GA approve the following distribution of Special Day Offering and Disciple Mission Funds giving from Georgia Disciples congregations received during 2016:

Special Offerings received by congregations and forwarded through the Christian Church in Georgia be allocated according to the General Board recommendations:

- a. Easter for General Church ministries
- b. Pentecost for New Church ministries (50% for Georgia & 50% for General)
- c. Thanksgiving for Higher Education ministries
- d. Christmas for Regional Ministries in Georgia
- e. Week of Compassion for Disaster Relief and Development
- f. Reconciliation for Antiracism ministries (50% for Georgia & 50% for General)

And that Disciples Mission Fund dollars received in 2016 from Georgia sources be divided as follows:

- 60% for the Christian Church in Georgia
- 6% for the Office of General Minister and President
- 34% for General Ministries and Higher Education institutions.

Business Item #2 Regarding the Regional Operating Budget for 2016

It is recommended by the Regional Board that the Regional Assembly of the Christian Church in Georgia meeting November 13-14, 2015 at First Christian Church of Atlanta in Tucker, GA approve the operating budget for the Christian Church in Georgia for the year 2016 as presented to the Assembly.
